The **Information and Communication Technology (ICT)** resources at Kangarilla Primary School are available for student use for **educational purposes**. To access these resources, all students and their parents must read and accept the conditions for use outlined below and then sign and return the “Conditions For Use” Agreement.

Students are required to follow the safety guidelines and ICT access rules when using the email, Internet and computer networks.

Student responsibilities

Students will:

- Keep their computer access password (when provided) confidential.
- Notify their teacher immediately if they accidentally stumble on an inappropriate site - the site can then be blocked. (No consequence will be applied if this process is followed)
- Use limited resources (i.e. disk space and printing capacity) thoughtfully
- Act respectfully and sensibly when using computers.

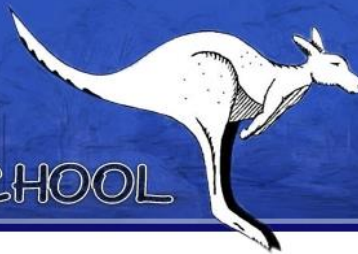
Students will not:

- Use a computer to offend or harass others
- Act unsafely or damage a computer or the network in any way
- Interfere with the operation of the network by tampering with existing software, or by installing illegal software, shareware or freeware
- Pass on personal contact details and information (their own or anyone else’s) over the internet or by email
- Access or enter another student’s computer documents, folders or files

Consequences for any breach of the ICT Contract Rules:

- First offence: The student will be banned from using the computers for any purpose for one week. Parents will be notified.
- Second offence: The student will be banned from using the computers for any purpose for two weeks. Parents will be notified.
- Third offence: The student will be banned from using the computers for a minimum of four weeks. Parents will be notified. Use of our ICT resources following this time will be under strict supervision for the following four weeks.
